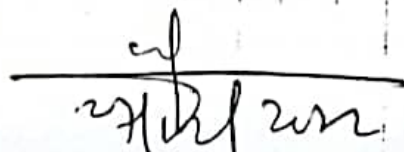

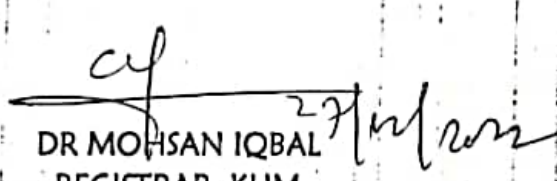

All documents should be attested, and application form should be complete in all respects. University is entitled to reject any incomplete application form.
7. The applicants for the post of Professor and Associate Professor must submit/attach four (04) DVDs pertaining to soft copies of all their credentials labelling folders, like Academic Credentials, Experience Certificates, Publications etc. along with the application/dossiers.
8. In case of publications, candidates are required to write proper title of the paper, complete authors list in actual order, name of the journal, and date of publication of those journals which are recognized by HEC. Publications with ambiguous information will not be accepted.
9. Applicants working on Regular/Acting Charge/Officiating/Ad-hoc/Current Charge and Contract basis in HEC recognized Public or Private Universities or Degree Awarding Institutes or Public/Private Sector Organizations (Including KUM's Employees) must apply through proper channel and attach NOC from their present employer and Experience Certificate/s from all former Appointing Authorities/Head of Institutions/Organizations within due date, otherwise their application shall be considered incomplete and liable to be rejected.
