5. Applicants having foreign degree/s will be required to provide Equivalency Certificate from HEC/ IBCC, Islamabad. within due date.

6. In case of a foreign degree or certificate, transcribed in any foreign language (other than English), an English translation must be provided from a recognized institute.

7. Distinction marks can only be granted after the provision of authentic document issued by the Controller of Examinations within due date.

8. Certificate regarding the percentage of marks will be provided from the concerned University/institution for those DMCs/Transcripts where a percentage is not mentioned.

9. Eligibility in all respects shall be reckoned up to the closing date.

10. Candidates must meet minimum and maximum age limits on closing date of application submission. However, age relaxation, for appointment by initial recruitment, shall be admissible as per policy of the Government of Punjab.
